Applicant: City of San Dimas

Environmental: Categorical Exemption, Section 15307, which exempts actions taken by regulatory agencies, as authorized by State law, to assure the maintenance, restoration, enhancement or protection of a natural resource where the regulatory process involves procedures for protection of the environment. The adoption of this Ordinance is required by Executive Order B-19-25 and will result in the enhancement and protection of water resources in the City, and will not result in negative impact to the environment; therefore, it is exempt from the provisions of CEQA and no further environmental review is necessary.
